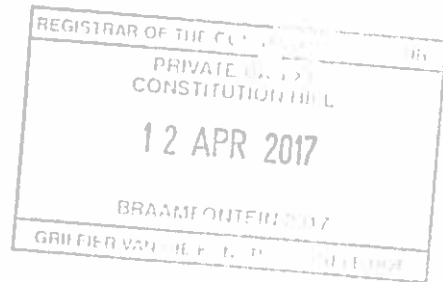
The Chief Justice has issued the following directions:
