## To the Addressees

As a persecuted forensic investigator, formerly employed by the Nelson Mandela Bay Municipality I wish to furnish information and evidence to you with the hope that this matter gets the desired attention.

For this purpose I am <u>attaching two affidavits</u> which are part of arbitration proceedings. These affidavits will furnish you an indication of what has been happening, especially since I have been subjected to inhumane persecution by both the DA (especially Trollip) and the ANC since 13 December 2016.

I have forwarded this information to numerous political parties and the State Capture Commission. The matter is under investigation by the HAWKS and NPA but only after it was escalated to the National Director: NPA, Adv Shamiela Bhathoi in that this investigation had been politically impaired for 3 years, which resulted in the removal of the investigator and NPA Advocate tasked with the investigation. Regrettably the current progress of the investigation is hardly satisfactory.

As forensic investigator I investigated the media contract with a certain MOHLALENG MEDIA, now known as MAVERICK STATE. The last mentioned company/s are directly linked to a ANC Stalwart named Cheslyn Mostert. The company was at all times a propaganda and political machine utilised for ANC political work only. It employed the services of politicians who were paid through this company who was awarded a contract through a tender process in the Nelson Mandela Bay Municipality. Several other municipalities afterwards piggy-backed on this contract and used this company mainly for party political purposes at the cost of the rate payer.

The recent publication of the bank statements related to the President's Cyril Ramaphosa's CR17 Campaign revealed the same individuals as common denominators, previously utilised through Mohlaleng Media. These role players, GRANT PASCOE (former DA City of Cape Town Councillor) and Vukil Pokwana together with Maverick State feature as recipients of monthly payments on the account of Linked Environmental Services, which is owned by DR CRISPIAN OLVER, another ANC STALWART and ANC HEAVY WEIGHT.

Whilst my responding affidavit is meant for arbitration processes due to unfair dismissal, in order for the ANC and DA to cover their filthy corruption tracks, it contains the gist of why I was persecuted and still have to endure such persecution through legal firms appointed by the very ANC cadre appointed by in executive positions in the municipality.

Cyril Ramaphosa claims to be addressing corruption within the ANC, yet does not address the issues regarding his CR17campaign, which resulted in funding via government tenders and not donor funding as alleged. The Public Protector was correct in wanting to refer the CR17 bank statements of Olver for investigation to the South African Police Service for investigation in respect of money laundering. Based on my extensive experience over 32 years in the investigation of fraud and corruption I confirm that the bank statements indeed show all hallmarks of money laundering and racketeering.

What is of concern is that the former Executive Mayor, Trollip actively protected his then City Manager, Johann Mettler and in particular Dr Crispian Olver. WHY? He was instrumental in having me as forensic investigator persecuted with false and malicious charges through legal firms linked directly to Olver and Mettler.

The investigation was to have been conducted by another external investigator, ADVOCATE Bruce Morrison, a former employee of the then Attorney General. He however knew Mettler from former assignments in the Groot Drackenstein Municipality, and instead of conducting the investigation in terms of the terms of reference, he became compromised and corrupted.

Thereafter Trollip interfered in the investigation and had the TOR changed, effectively resulting the intentional commission of anything that would even closely refer to Mettler and Olver, never mind other serious findings.

During March 2018 Morrison issued a very poor report, however it implicated a certain Noxolo Nqwazi as acting City Manager, who was appointed to the municipality as an ANC cadre. She is deeply implicated in numerous investigations and subsequent factual findings. She was responsible for the R 2.6 million golden handshake that Mettler received, whilst he is directly responsible for R 15 million in unauthorised expenditure, fraud, corruption and contraventions in terms of section 173 of the Municipal Finance Management Act.

After Morrison furnished his very poor report to the HAWKS with the intention to get the HAWKS off track regarding Mettler and Olver, it was established that Trollip had hidden report exhibits and documentary evidence that I furnished to Morrison at his residence for a period of 26 months. The HAWKS only seized these documents from him on 8 June 2020. The last mentioned resulted in me compiling additional, yet separate charges against Mettler, Morrison and Trollip.

I am addressing this introductory mail to gage your interest in fighting the fight of rampant corruption in South Africa and to expose this rot that eats away at society.
